




Weekly count of ED vists for influenza-like illness








Emergency department (ED) chief complaint and admission data for Clay County Daily percent of ED visits mentioning cough, fever, or shortness of breath








Daily percent of ED visits resulting in cough-associated admissions











Weekly count of ED vists for influenza-like illness











Daily percent of ED visits resulting in cough-associated admissions






Daily percent of ED visits resulting in cough-associated admissions






