Daily percent of ED visits mentioning








Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Santa Rosa County










Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Sumter County










Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Taylor County










Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Union County











Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Volusia County



Daily percent of ED visits mentioning









Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Wakulla County



Daily percent of ED visits mentioning









Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Walton County



Daily percent of ED visits mentioning








